

LIST OF REGISTERED AND APPLIED ADMINISTRATIVE EXPENSE RATES

Upon distributing royalties to rights owner authors, composers and music publishers who have entrusted their rights to JASRAC, a specified rate (administrative expense rate) of the amount to be distributed is deducted as administrative expenses, to be used for business operations.

The administrative expense rates that are actually applied (applied rates) are determined with the approval of the JASRAC Board of Directors, within the limits of the administrative expense rates stipulated in the “Stipulations for Administration Trust Contract” that is notified to the Agency for Cultural Affairs (registered rates).

ⁱ “Major Live Concerts, etc.” mean concerts for which the “amount obtained by multiplying the admission charge by the capacity” per performance based on the tariffs for “concerts and performances etc.” exceeds 50,000,000 yen.

ⁱⁱ With regard to royalty amounts designated by trustors, 8% is applied to the portion of the amount up to 3,000,000 yen, 2% is applied to the portion exceeding 3,000,000 yen and up to 10,000,000 yen, and 1% is applied to the portion exceeding 10,000,000 yen. When trustors do not designate royalty amounts, licenses will be issued based on royalty amounts prescribed in the Tariffs for Use of Musical Works depending on the form of reproduction. Therefore, the administrative expense rate for the corresponding royalty category will be applied.

ⁱⁱⁱ Administrative expense rates for “Others” are determined separately by the Board of Directors and are all below 25%.

^{iv} The applied rate for Broadcasting is applied in accordance with the provisions of Appendix 2 of the “Rules for Distributing Compensation for Video Home Recording” that constitutes the “Stipulations for Administration Entrustment Agreement” to add up and distribute to the TV broadcasting distribution fund.
